**FINANCIAL AGREEMENT**

- ANNUAL PAYMENT (2 percent discount, due by August 1<sup>st</sup>).

We agree to pay any curriculum fees, lab fees, sports fees and fines as they occur during the school year. We understand that report cards and school records will be withheld if required payments are not made in full.
